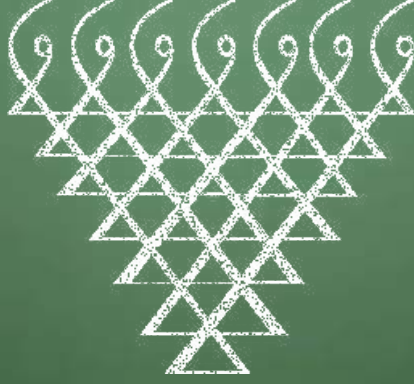

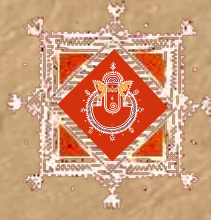

## Dr. Vasantji V. Bang

Dr. Vasantji Bang is a professor of management and strategic management advisor to corporates. He holds PhD from BITS, Pilani. He was the founder member and later Secretary and Chairman of MVPM's Maheshwari Scholar Awards Committee.

### Yes, education does matter!

There is a vast change in socio-economic scenario of the country in general and Maheshwari community in particular between the time when MVPM was founded more than 90 years ago and today. No one more needs to emphasize importance of education. Now the goal post has shifted from getting educational qualifications to getting educated in world class institutions and universities. Hence, exactly 10 years back, Maheshwari Vidya Pracharak Mandal (MVPM) decided to take its work in the area of education to next level. In 2012 MVPM's Maheshwari Scholar programme was conceived with the objective of bringing before the community such young role models that can serve as inspiration. Though IIT, IIM, AIIMS, Cambridge, Harvard have become aspirational benchmarks, one sometimes gets a feeling that these institutions are seen primarily as gateway to great careers besides highly glamourised brands. I can say this with some confidence as not only I have been a founder member of MVPM's scholar awards committee and later chairman but also as an educationist and a management consultant.

It is not uncommon to hear sermons like "Being practical is more important than educational qualifications." The sermonisers often quote examples of JRD Tata, GD Birla, and Dhirubhai Ambani. However they forget that all of them sent their future generations to best universities in the world for higher education. GD Birla set up India's one of the premier engineering institution, BITS, Pilani; in his native village. In fact Bill Gates, whose case is also often cited as example of a college dropout making it real big, has himself on record said that his is not the right example to emulate as chances of being successful are much higher for educated people than otherwise.

"What we studied in schools and colleges was not of much use. Practice is different from theory." This is a common complaint against education, specifically formal education. There always exist scope for improvement in curricula, teaching and evaluation methodologies. But that does not mean education has no relevance in real life. In order to appreciate this argument one needs to understand neurological basis of learning. But before we do that we need to be clear about what learning is? Learning, simply means relatively permanent change in way of thinking and behaviour.

Human brain comprises around 86 billion neurons. Each neuron is chemically etched with information that we receive genetically as well as socially. We pick up information through our five senses (sight, smell, hearing, touch and taste) from our families, surroundings, schools, colleges, social interactions, commercial and other media. Faced with any specific situation, neurons from different parts of the brain fire together to produce a thought which may produce action. This

phenomenon can be explained with an interesting experimental research cited by Nobel laureate Daniel Kahneman in his book 'Thinking Fast and Slow.' Participants in an experiment were induced to lie to an imaginary person either on phone or in an email. In a subsequent test of desirability of various products, people who had lied on phone preferred mouthwash over soap, and those who had lied in a email preferred soap to mouthwash.

A possible explanation of this phenomenon is as follows. In human brain, different pieces of information related to various aspects like lying, sin, washing, mouth, hand, mouthwash and soap are etched on different neurons. In the brain of some of the people who lied on phone, neurons related to lying, sin, washing, mouth and mouthwash might have fired to produce a thought that lying is a sin - sins can be washed and since mouth was involved in committing the sin, a mouthwash is preferred. Participants involved in this experiment may not agree with this line of reasoning for their preference to mouthwash / soap. This is because the neural connections get formed unconsciously and human beings are not aware of it. Professor Gerald Zaltman of Harvard Business School says that up to 95% of human thinking takes place at subconscious level.

It is not uncommon that we experience some sort of flash in specific practical situations. This flash is nothing but activation of neural circuits in brain, made possible because some information existed somewhere in the brain. For instance, at some point (I don't remember exactly when) in my professional life I realised that 'learning to learn' is the most important quality a manager needs. This is because management is highly contextual practice and one can not have a standard response to every situation. One needs to keep learning from unstructured situations to deal with future problems. Hence, more than management tools and techniques, one needs to learn 'how to learn'. Now when I look back, I realise that this flash that occurred to me is not my original invention. I had studied the concept of learning in subjects like Organisational Behaviour, Consumer Behaviour, and Marketing Communication in my MBA programme. There after I had attended a workshop on learning styles as a young faculty member, listened to an address on 'learning to learn' and read Henry Mintzberg's book titled Managers, Not MBAs. Probably this flash about 'learning to learn being an important prerequisite to be a good manager' is a culmination of all this. Hence, just because we are not able to connect the dots consciously, does not mean that all that we studied, read, listened to; was useless.

So how does one use this insight. First, get exposed to high quality education, literature and talk so that neurons in our brain absorb as much as possible though while doing so we do not know when, and how will we retrieve a specific thought. The educational exposure comprises three broad types: information, analysis (breaking things into parts) and synthesis (putting parts together). For instance, in our schools we learnt that everything is made up of molecules & atoms and atoms in turn are made of subatomic elements like electron, neutron and proton. This is the information part. But in order to solve a problem one should break it into its indivisible parts (like subatomic elements) or if some pieces of information are available one should try to connect the dots, is a way of thinking. In order to develop this, one needs to expose oneself to variety of situations in which dispersed and yet related neurons will be required to fire. More frequently a neural circuit is used, more it gets strengthened, i.e. faced with similar situations the neurons would fire together.

Hence, as they say there is a method in madness. Just because we are not able to recall and connect what all we had studied, read or listened to at different points in our life, does not mean all that is useless. Education and erudition indeed matters in practice.

We have seen many cricket matches, Football matches or other sports too, when during the last few minutes of the game, the end result changes. A researcher fails many times before he succeeds. We need to view failures as success delayed than defeat. Patience and perseverance is the name of the game. We should not allow our pursuit of excellence to end abruptly!

One must cultivate a positive approach and positive thinking for rising above. Our past experiences sometimes drag us behind. Getting tagged to past can result in negative thoughts and self-doubt but a positive thought drives the adrenaline through our body and mind. It becomes a source of energy. A passionate person focussed on his goal experiences this. The famous Korean entrepreneur Kim Woo Choong once said, "An artist who goes to countryside to paint scenery looks at only the good scenery". He used to say, "When others try to find out why a sick unit became sick, I always tried to find out how it can be made profitable". In reality, hope is a great motivator. Just 1% of hope of success can keep you running for it, if you remember, just one spark ignites a high-power engine to release huge power for work. Only positive thought can transform you from a loser to a winner.

A strong will & self-determination wins half the battle for you. Sudha Chandran, the famous Bharat Natyam artist had lost her legs due to an accident. Everyone thought it was the end of her dancing career. But she did not give up. In just two years, she returned to the stage with artificial Jaipur foot and continued her passion. Arunima Sinha, a National volley ball player was thrown off a running train damaging her legs. But she chose to fight for her dreams and within two years became world's first amputee to scale the heights of Everest.

An open mind is a great asset. In today's world, flooded with innovative ideas, one needs to go beyond the boundaries created by the established thought process and accept new thoughts and ideas. One has to be at least ready to examine such ideas before rejecting them. Children are good at box-less thinking. You will always find them enjoy their games with whatever resources are

available to them. They will find ways, sometimes symbolic, to fill in the gaps due to lack of facilities. This is because they are focussed on the outcome they want with open mind.

And, one has to find out a purpose of one's existence on this beautiful earth! Those who do, get self-motivated and dedicate themselves to the cause. They become beacons for others. That is why Bal Shivaji became Shivaji Maharaj and Mohandas Gandhi became Mahatma Gandhi. Decades and centuries after their departure, they still continue to inspire lives of many.

## Patanjali's Success Mantra: 6 x 6

Did you notice that amongst the people you know around you having comparable intelligence, qualifications / education, experience, skills, competencies and even intents, **“Only a few succeed while most don't”**. Such examples abound just about everywhere in life in schools, colleges, sports, professional careers, business etc.

Did you ever ponder on this paradox? and what have been your findings?

It's not that you find such phenomena only in recent times but that this has been happening over millennia. Many scholars and philosophers have attempted to find answers to the questions raised above. Patanjali the great scholar, philosopher and mystic is perhaps the first on record to come up with a logical and lucid explanation of this paradox.

In his seminal treatise “Patanjali Yoga Darshan” he lists several reasons as to **“Why only a few succeed?”** Let's look at the 6 most important reasons as under - **व्याधी**: Handicapped, Physically challenged: This is easy to understand; handicapped person obviously has limitations to succeed in that domain where the handicapped restrains him from being successful. For instance someone with severe speech and autistic disabilities can hardly aspire to be a successful lawyer.

1. **आलस्य**: Laziness - Unwillingness to work or put in sincere efforts is the major reason for people not to be successful. We see many such people around us in our family, in friends and in the society. Ironically, these people don't accept that they are not successful because of their laziness, readily blaming instead their misfortune or bad luck.

2. **स्त्यान**: Mental laziness - This is an interesting observation by Patanjali. There are two kinds of laziness existing in human beings, first as described above, let's call it as physical laziness and the second is mental laziness. These people are physically active, they don't have any problem in putting in strenuous efforts but they have a mental block or mental laziness to do the things on time and end up taking it easy.

3. **संशय**: Doubtful, Fear of failure - Many people are plagued by self-doubt even before taking up an assignment or an activity, usually ending up in a self-fulfilling prophecy.

4. **भ्रान्ती**: Wrong priorities - You will find many such examples particularly from the unsuccessful



people. In schools and colleges, though everyone wants to score high marks they instead of concentrating on studies and attending classes regularly waste time on extraneous activities. Likewise, in professional careers, instead of doing the work correctly, in time they waste their time in gossiping and engaging in unwanted activities, eventually failing to build a successful career.

5. **अलब्ध भूमिकत्व** : Overconfidence - These people are either overconfident or they pretend that they know everything when actually they know very little. This is an interesting observation by Patanjali. You come across many such people who claim that they know everything under the sun a la Google website. This prevents them from learning things they ought to know often leading to failure.

While these 6 are important reasons why people are not successful, the question remains as to whether avoiding these pitfalls would necessarily lead one to success? While nothing is guaranteed in real life, the chances are, it will.

Further in one of the discourses of Shri Sudhanshu Ji Maharaj, noted guru, has listed six ways to be successful from our Vedas and Upanishads. Propounded in antiquity, these reasons and ways are still valid and relevant in today's modern world.

1. **लक्ष्य** : Goal - To be successful one has to first decide on the Goal which should be SMART meaning: S - specific, M - measurable, A - achievable R - realistic and T - time bound.

Whether you are a student, job seeker or in a career; in sports or in business. You need to first set a goal on what you wish and want to achieve.

2. **त्याग**: Sacrifice - An important requirement to achieve your goal is that you may need to sacrifice several things be it your comforts, your other priorities or even your relations. After all it's a give and take i.e. to get something you have to give up something else.

3. **ध्यान**: Focus - Once the goal is set, one needs to be focused on it for all the time. Many people do not succeed because they lose sight of the goal or even forget it altogether. Your focus should be like the legendary focus of Arjun in the epic 'Mahabharat' when he shot his arrow through the eyes of the rotating fish

4. **साधना**: Sustained efforts. There are no free lunches in life, one has to put in adequate efforts to get what they desire. Continuity and consistency in efforts is the only way to be successful.

5. **धृती**: Determination - You need to be determined to reach the goal, should never think of giving up half way. Extreme determination combined with sustained efforts leads to the success

6. **करुणा, अहिंसक** : Compassion, nonviolence—Another important quality you need to have is to be compassionate and non-violent in your approach in deploying your energies and resources towards achieving the goals. Nonviolence doesn't just mean avoidance of fisticuffs and bloodshed, rather it also means refraining from verbal abuse and politeness of behavior.

These are a few of my humble compilations of wisdom over the years, thanks to the people I met, books I read and the illuminating discussions with friends. I find them quite relevant and applicable whenever I come across both successful, and not so successful, people.

If you want to be successful, keep this 6 X 6 formula handy and apply its principles whenever necessary. Though it may not guarantee you success, trust it will improve your chances manifold.

## Chartered Accountant – an excellent course to multiple career pathways and some perspectives from my consulting journey

If you are pursuing a Chartered Accountant course or have freshly become a Chartered Accountant, this article is for you. CA is a course that gives you the armory to conquer whatever you aim for, I often say that this course is means to the ends you want and not an end itself. This course and the journey of completing this course will give you so much confidence and prepare you for any challenges that comes your way in the career.

This is a course that provides you multiple career options. I always tell students and fresh graduates that each subject in CA final is a functional career option that they can explore ranging from direct & indirect taxation, auditing, financial management, cost management and budgeting, strategic management, and so on. Specially at the start of the career it is important to build clarity on 3 important questions, which you should be exploring answers to throughout your articleship:

### 1. What do you want to do?

What is the field which interest you the most? Do you like to solve taxation cases, or do you like to solve cost management issues for the company? Or do you find statutory auditing and reviews interesting? Which sectors do you find interesting? Is it banking and financial services or is it manufacturing or is it BPO sectors (for example)?

It will require you to build a sufficient understanding of the sectors and functions to answer this question. This understanding can be built through observing the roles and sectors you see during articleship, doing a lot of desk research and talking to people in those sectors.

### 2. Why you want to do it?

This is an important double click of the first question. Do you want to do banking just because you thought it is cool from a movie or do you love numbers and love to model scenarios and design new products?

Always note down and see whether you have strong reasons to select the sectors & functions as your interest areas which you selected in “What do you want to do”.

### **3. How can you do it?**

There will always be several options to do what you like. Eg. If you like Taxation you can set up your own practice or you can take a job in one of Big 4s in taxation departments. If you like Strategy – you can aim for a job in one of the Big 3s or you can take up a strategy role in a start-up.

Look at profiles of a lot of people in the sector and fields that you find interesting and see the career paths taken by them. Talk to as many people as possible. Make LinkedIn your tool for this.

I took the path of strategy consulting after completing CA because I like solving problems of different type by first principles and I like to work in multiple sectors. Strategy consultants are professionals who advise organizations on high-level decisions through an analytical approach and bring in an outside perspective.

Consulting has provided me opportunities where I have been able to work on number of sectors and wide range of problems. Some examples of projects I have been part of include EBITDA turnaround of a steel manufacturer; logistics cost optimization for a cement manufacturer; drafting policies for multiple ministries of the government in India and Middle East across sectors such as agriculture, infrastructure, logistics & transportation and economy; US animal medicine market entry strategy for a pharma player; US bed sheet market entry strategy for a textile player. The list goes on.

Of course, these projects required me to do a lot of research and study before I could work on them. Eg – when I was working on “US animal medicine market entry strategy for a pharma player” project, I had to learn in depth what are the active pharma ingredients (APIs) of making medicines for animals, how complex is each medicine to make, what are the approvals required to launch any medicine in US and so on. But I am glad to say that I found myself so well equipped to take on any of these challenges because of the skills gained from CA course. This skill is “Learning new topics and new subjects” and to breakdown complex problems into small part and then solving these parts one by one to reach the overall answer.

There have been multiple learnings from the course which have helped me directly as well on different projects such as ability to read and analyze financial statements, solve complex quantitative problems such as optimization of networks, activity-based costing, turnaround time (TAT) analysis etc. But larger focus has been not on applying the existing solutions but to break the problem at hand and find new solutions. Critical thinking and problem solving has been at core of most of work done on strategy front.

As Archimedes said that if he were given a long enough lever and a place to stand, he could move the world. And this Chartered Accountant course provides us that lever. It is on us to create our standing and move the world.

## The Genesis

Maheshwari community is considered to be one of the leading business communities in India. Economic contribution of Maheshwaris has been well acknowledged. While being at the forefront of business, industry and trade, Maheshwaris have achieved exceptional feats in educational pursuits too. But business achievements of Maheshwaris are so overwhelming that the community's academic achievements go unnoticed. Having realized this Maheshwari Vidya Pracharak Mandal (MVPM) decided to make its humble contribution towards correcting this perception. As a step in that direction MVPM instituted MVPM's Maheshwari Scholar Awards in 2012 aimed at giving academic recognition to the community which it deserves. The awards recognize extraordinary scholastic achievements of such Maheshwaris who can serve as role models for the youth of our community.

## The Award

The MVPM's Maheshwari Scholars are identified from among Maheshwari students all across the globe with outstanding academic records in higher education. They come from very diverse backgrounds like Engineering, Medical, Finance, Management, Law etc. Besides, Ph.Ds & UPSC qualified candidates are also eligible to apply. In selection of awardees there is no fixed number of awards for various educational disciplines. In extreme case all can be from same discipline & none can be from a specific discipline. Neither is any consideration for gender or economic background of applicants. The applicants are evaluated primarily on their scholastic achievements.

In all there are three category of awards, viz. Maheshwari Scholar Award, Promising Maheshwari Scholar Award and Emerging Maheshwari Scholar Award. Each Maheshwari Scholar & Promising Maheshwari Scholar is given a Gold Medal worth Rs 50,000 & Rs 25,000 respectively besides Citation. Emerging Maheshwari Scholars are given a citation. In order to recognise any exceptional talent among chosen awardees there is a provision for Outstanding Maheshwari Scholar Award. Besides, a 'Maheshwari Scholar Icon' award in the form of a citation is given to a senior Maheshwari for his/ her scholastic contributions over several years.

## The Selection Process

To be eligible for awards one needs to apply in a structured format specified by Scholar Committee. There is also provision for online submission of application forms. There is no provision for nomination in student category. Only candidates who have passed their under-graduate (UG) or Post-graduate (PG) exams or obtained Ph.D or qualified UPSC between 1st October of preceding year & 30th September current year are considered eligible.

From all the applications received, applicants with outstanding scholastic record are shortlisted for a telephonic interview with a jury comprising people who have themselves been scholars and have related achievements to their credit.

On the basis of evaluation by the jury a certain number of awardees are chosen as Maheshwari Scholar, Promising Maheshwari Scholar and Emerging Maheshwari Scholar. Maheshwari Scholar Icon awardee is nominated and chosen by the Managing Committee. There is no provision for application in this category.

## The Scholars

The applicants for Scholar awards come from all across the globe including Australia, USA, UK, Germany, Spain & Japan. Within India they come from various states like Andhra Pradesh, Chhattisgarh, Gujarat, Karnataka Madhya Pradesh, Odisha, Rajasthan, Tamil Nadu, Telangana, Uttar Pradesh, West Bengal, and of course Maharashtra.

Over the years Maheshwari Scholar Awards have been scaling newer heights in terms of scholastic achievements. Here is a sample of few achievers. Dr Dinesh Bharadia the recipient of Outstanding Maheshwari Scholar award was included in Forbes list of America's top 30 under 30. Dr Zarana Maheshwari, completed her Ph.D in English Literature with flying colours despite having lost her eyesight. Nishant Totla, the 2012 awardee had received all India rank 2 in IIT – JEE, which is described as world's toughest entrance exam. Another scholar Sanjay Navandhar achieved all India rank 1 in the prestigious CA exam. Laya Maheshwari, one of the awardees went for further studies to Harvard Law School. Darshit Jaju, an IIT – IIM alumnus, was included in The Economic Times top 50 Emerging Leaders of Corporate India.

Eighty four Maheshwaris who received Scholar and Promising Scholar Awards in last seven years include fifteen Ph.Ds from top global universities like Stanford, Cornell, Massachusetts University and INSEAD etc; twenty one engineers from IITs, BITS, Pilani, Georgia Tech, etc; eighteen doctors including super specialists like DM and M.Ch and alumnus of AIIMS, New Delhi; thirteen finance professionals including CA AIR 1, 3 & 5, CS AIR 2 and CMA AIR 8; nine management postgraduates all from IIMs or XLRI; five Public Service Exam qualifiers like IPS, IRS etc; and three from humanities side from top institutions like Cambridge University, London School of Economics, and New York University. 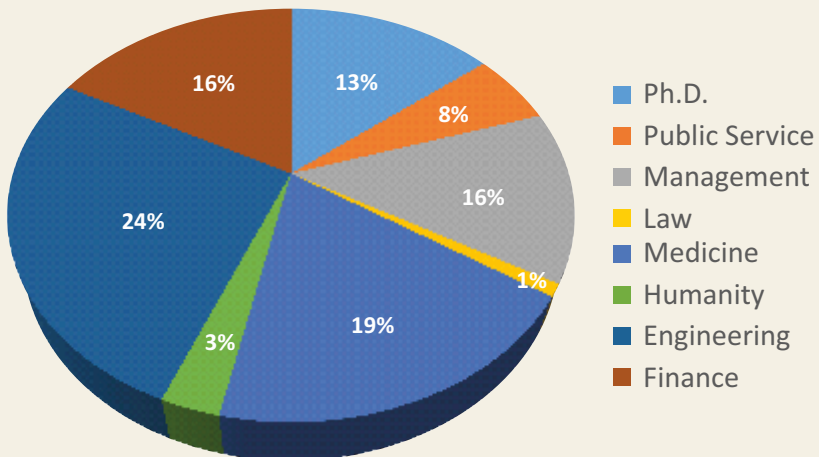

In the first year awardees were chosen from engineering and medicine disciplines. In all five MVPM's Scholar awards were given in the first year. Each award comprised a cash component of Rs 50,000 and a citation. Gradually, over the years, new educational disciplines were added to the award category and now it is free for any discipline of higher education. With increase in the number of applicants from all over the globe, it was decided to not only increase the number of awards to be given each year but also Promising Scholar category was newly created. Later on Outstanding Maheshwari Scholar award category was also created but only as an exception. It has been restricted to only the cream-da-la-cream among the scholars. In last seven years this award has been given once.

The selection process also evolved with experience to include a telephonic interview round. It was realized that all those who get shortlisted for interviews but do not qualify as Scholars or Promising Scholars also deserve to be recognised for their scholastic achievements. As a result a new category of awards, the Emerging Maheshwari Scholar, was added.

A new category of award titled 'Maheshwari Scholar Icon' was instituted in 2018 to honour a senior Maheshwari for his/ her scholastic contributions over several years. The maiden Maheshwari Scholar Icon was presented to Professor (Dr) Rajat Moona, Director, Indian Institute of Technology (IIT), Bhilai.

The mission of promoting world class academic excellence in higher education should guide all future decisions and activities related to scholar awards. Completely impartial selection of awardees by independent jury with impeccable academic credentials has been the key to success of scholar awards over the years. More than recognising the talent of outstanding Maheshwari students, the scholar awards have become a platform to showcase world class excellence and inspire the future generations of Maheshwari community. Experience of last seven years shows that almost all scholars are recipients of multiple awards, scholarships and fellowships that too from very reputed organisations and yet Scholar award holds a special place as it comes from the community. It is worth reminding ourselves that 'MVPM's Scholar Award' was rechristened as 'MVPM's Maheshwari Scholar Award' to lend that community feeling to the awards. This sanctity has been upheld all through thanks to the generous sponsors who never expected that their names be included as part of the medal, citation or even on banners as presenters of the award. MVPM can take immense satisfaction in the fact that MVPM's Maheshwari Scholar Awards have outgrown and have become a part of entire community's treasure.

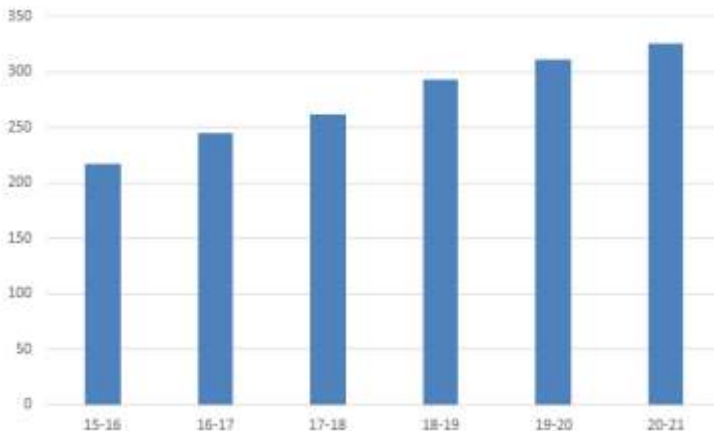

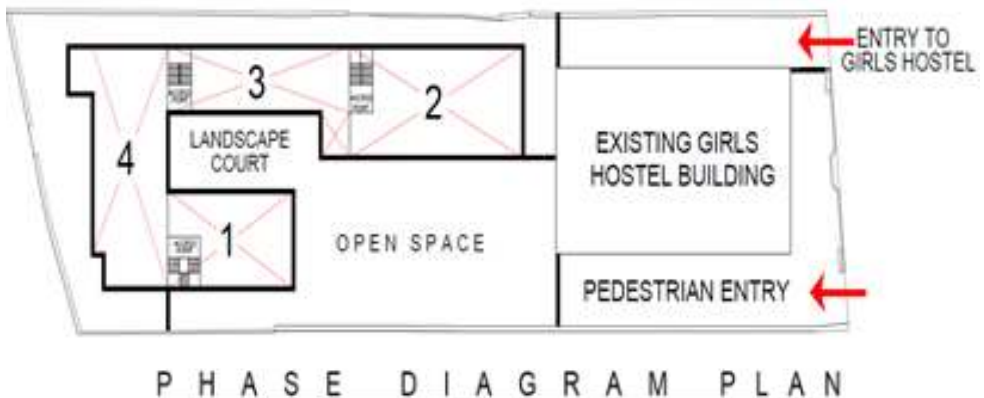


## 2) V.N.Lahoti Hostel Redevelopment Project

We are happy to inform you that construction of 5<sup>th</sup> floor at H.R.Rathi Hostel is completed .The 5<sup>th</sup> Floor consists of 10 rooms and reading room facility with all ultramodern facilities such as High speed internet connection ,AC Conference room etc . Construction and furniture cost is Rs.1.7 Crores.



## 7) The Reading Room at V.N.Lahoti Hostel

AC reading room with capacity of 40 students and Multipurpose Hall was completed at V.N.Lahoti Hostel at the cost of Rs.14.84 Lakhs.

# Ongoing & Future Projects of MVPM

## Redevelopment of VN Lahoti Hostel

Almost 80 % work is done of redevelopment project of VN Lahoti Hostel. Once completed, it will house @300 students. It will be equipped with all facilities like, Wi-Fi, Gym, Mess, Dining Hall, Auditorium Hall, Reading room, Rectors quarter, spacious parking and open area for the function of 400 people. It is being made at the total investment of Rest 16 Cr and should be fully functional by March 2023.



## Airoli Girls Hostel

The construction for this flagship project of MVPM is going on in full swing. It got delayed due to pandemic and hard rock in basement. However, it is expected to be ready for occupancy by March 2023. CIDCO has recently granted additional two floors and the capacity of girls will be increased from 84 to 126 with total seven floor. All the rooms and Dining facility are air-conditioned. Total Rest 8 Cr donation has been promised for this project of Rest 11 Cr. Once it is ready, it is expected to be first choice for the girl students coming to Mumbai for higher education. It has got good connectivity with railway station of Airoli, Mulund & Thane.



## Kothrud Complex

The drawings for this very ambitious project of MVPM is submitted to authorities and expected to get sanction by Aug 2022. It will have expansion of existing school to make it future ready. It will also have residential skill development Center, a need of time. The project cost is @ Rest 25 Cr and expected to be funded by donations & CSR funding.
